If you know a good CCA Candidate, please encourage them to consider taking a study course! Two different study courses will be offered in Illinois in 2023. Information will be posted to the CCA website when available. Many companies are also planning internal trainings. The exams are difficult because as YOU know, CCAs are expected to be able to demonstrate a baseline of applied knowledge before they can be certified. Online exams make it possible for people to take the International Exam and Tri-State Exam on different days at a time they are most comfortable with testing. It is important that all directions are followed to make sure the exam goes smoothly. Specialty certifications (4R Nutrient Management, Resistance Management, Precision Agriculture and Sustainability) are all offered on demand now too!

You can receive credit for watching any videos or events that are related to the Continuing Education Standards. Activities that are eligible for credit are classroom training, workshops and field days. The link to self-reported CEUs is on the right side of the certifiedcropadviser.org website. <u>Reminder</u>: you need to have 20 approved CEUs before the 20 self-reported count.

<u>Online CEU Subscription makes it EASY, convenient</u> and cheaper to get those last minute CEUs

Over 200 online CEUs and webinars are now available with a \$100 Classroom Subscription at the American Society of Agronomy Website. Instead of paying for each individual CEU, you can now purchase the annual subscription for \$100 and have access to unlimited content! You can get all 40 CEUs for the \$100 subscription fee

Life Changes Policy

CCAs who do not have enough CEUs for their cycle can <u>appeal</u> or they can also <u>request inactive status</u>, if they want to put their certification on hold due to illness, injury, maternal/parental leave, military service, or death in the immediate family. The CEU Application Process is also simple if you host a meeting. If you have an agenda and speaker info it will take less than 10 minutes to get an application submitted.

<u>Webinars</u> are a great way to earn Approved CEUs from the convenience of your home or office. When you watch these LIVE, and an application for pre-approved CEUs has been granted, you will receive approved CEUs. There are many pre-recorded FREE webinars online for those who cannot attend LIVE to watch later. You can do this and then go online and report the webinar as a self-reported CEU.
